### \$3,485 Awarded in 2017

The Mott-Regent Community Foundation Advisory Committee awarded a total of \$3,485 in three different grants to the following organizations in 2017:

- \$2,500 to **Hettinger County Historical Society** for exterior painting and signage
- \$385 to **Mott-Regent School** (through the Missouri Slope Areawide United Way) for the school's backpack program, which will provide 77 meals for children to bring home with them over the weekends.
- \$600 to the **City of Mott for the Mott Public Library** to purchase additional items for their Maker Space area, including a Cricut Explore Air machine (pictured below) and a Rule Your Room kit.



Grants are awarded from the fund's earnings once a year. Any organization with a 501(c)(3) status or government agency is encouraged to apply. Approximately \$5,600 is available to grant out in 2018. ## Estate Gift Benefits Area Forever

Ishmael Diede was a local community photographer in Mott, North Dakota. Both he and his wife, Rose, graduated from Hebron High School in 1939. They were married in 1942, and together they operated their own photo studio in Mott for 38 years, providing services to a wide area of southwestern North Dakota. Rose and Ishmael retired to Bismarck in 1985 and Rose passed away in 2005. Ishmael wished for his estate to continue to benefit the communities that had supported him and his wife Rose throughout their lives.

Ishmael left a \$1 million gift to the North Dakota Community Foundation in his will. Per his desire, half of the money was used to create the Ishmael & Rose Diede Charitable Scholarship Fund, which provides over \$20,000 every year for scholarships to area youth.

The other half of his estate was used to establish four community foundations in the area: New England, Mott-Regent, Glen Ullin, and Hebron.

## Ways To Give: Options to Grow Our Fund

There are many easy ways to support our community's permanent endowment fund:

- **Write a check every year on your birthday.** Together, these gifts from area residents would grow our fund into a huge resource for our school, park district, and other nonprofit organizations! 
- **Establish a Charitable Gift Annuity** through the North Dakota Community Foundation. You will receive an annual payment for the rest of your life, and the Mott-Regent Community Foundation will get the remainder of your gift when you are gone.
- **Leave a portion of your estate to the fund.** You can leave a certain amount, a percentage of your estate, or the remainder of your estate (after designating gifts to your children or friends) to the Mott-Regent Community Foundation. Contact an attorney to help you set up your will.
- **Donate agricultural produce.** This is an easy way to give without having to open your checkbook! Producers don't have to claim the income from the sale and they can still deduct the cost of production for whatever they donate. 
- **Make the fund a full or partial beneficiary of your life insurance policy.**
- **Make a gift in memory of a loved one.**
- **Businesses:** donate a percentage of your net profit at the end of the year. Having a strong community with valuable services for residents improves our quality of life and is good for business!
