\$9,880 Awarded in 2023

This year, the MCF Advisory Committee awarded a total of \$9,880 in 7 different grants to the following organizations and projects:

- **Maddock Community Center Corporation:** \$2,000 for the women's bathroom remodel
- **Maddock Community Historical Society:** \$2,000 for a new museum building
- **Maddock Sports Boosters:** \$1,500 for Maddock football field updates and renovations
- **Maddock Opera House Association:** \$1,500 to refinish the hardwood floor on the main level
- **Maddock Community Library:** \$1,000 to purchase a laminator
- **Maddock Economic Development Corp:** \$1,000 for billboards for the Renaissance Festival
- **Maddock Memorial Home:** \$880 to upgrade our flower beds

There are over 69 local community foundations in North Dakota, some that started over three decades ago and others that started last year.


The larger these permanent endowment funds grow, the more earnings are available for grants every year. Some funds award over \$40,000 in grants every year!

- **Take advantage of the tax credit!** Individuals that give at least \$5,000 in one calendar year and businesses that donate
