## \$26,090 Awarded in 2023

The Larimore Community Endowment Fund was created to be a resource to support local community initiatives which provide a higher quality of life in the Larimore area. The community also receives grant dollars every year from the Vernon & Lila Halvorson Endowment Fund and the Charles D. McCanna Fund.

Recently, the Foundation's Advisory Committee granted a total of \$26,090 from these three funds to the following organizations:

- Bellevue Cemetery Association: \$5,000 for beautification, maintenance, and upkeep
- Larimore Football: \$5,000 for equipment upgrades
- Larimore Museum: \$5,000 for community grounds improvement and a gazebo
- Edna Ralston Public Library: \$5,000 for their summer reading program and general operating expenses
- Radiant Little Lambs Daycare Center: \$3,000 for a storage shed/plumbing update
- Larimore Fire Protection District: \$1,090 to help replace water holding tanks
- Larimore Senior Citizens Club: \$1,000 to install ceiling fans in the main area
- Larimore High School After Prom Party: \$1,000 for the 2024 After Prom Party

#### Generous Tax Credit Provides Big Incentive To Give

Are you able to make a more substantial gift to our community foundation? If so, you may be interested in the significant tax benefits available to you.

The North Dakota Charitable Income Tax Credit, passed by the ND State Legislature in 2011, allows individuals that donate \$5,000 or more and businesses that donate any amount to qualified endowment funds to receive up to a 40% state tax credit.

The Larimore Community Endowment Fund (LCEF) is managed as a "qualified endowment fund" so donations may qualify for the tax credit if they meet the above criteria. Several donors have already taken advantage of this incentive and contributed to our fund.

Depending on your tax bracket, this means a \$5,000 gift to the LCEF may end up only costing about \$2,000 after taking advantage of the tax credit and other deductions! (see chart below)

Gift Amount	\$5,000	\$10,000	\$25,000
Estimated Federal Tax Savings	(\$960)	(\$1,920)	(\$4,800)
ND State Income Tax Credit	(\$2,000)	(\$4,000)	(\$10,000)
Net Cost of Gift	\$2,040	\$4,080	\$10,200

The credit can be carried forward for three additional tax years, if it cannot all be used in one year.
