# Centennial Commission Donates \$25,000 to Endowment Fund

The Wishek Centennial Commission (WCC) donated \$25,000 to the Wishek Area Community Foundation (WACF) in August after the community's centennial celebration.

"We had enough money so that all the activities for the 125th celebration this summer were free, including the band Hairball," said WCC treasurer Greg Salwei. "There was money leftover after all the expenses were paid and we wanted to put some of it back in the community."

The WCC was established many years ago for the town's centennial celebration in 1998 and was incorporated in 1993. In addition to the donation to the community foundation, the WCC also donated \$50,000 to the Wishek Pool Renovation Project and invested some money to grow over time for the 150th celebration.

The \$25,000 donation to the WACF is the largest single donation in the fund's history.

"We are so thankful to the Centennial Commission for this gift," said WACF Chair Debra Dohn. "This fund is a permanent resource



for Wishek so it's a great way to give back to our community."

There are over 69 local community foundations in North Dakota, some that started over three decades ago and others that started last year.


The larger these permanent endowment funds grow, the more earnings are available for grants every year. Some funds award over \$40,000 in grants every year!

- Take advantage of the IRA
   Charitable Rollover your donation
   (directly from your IRA to NDCF for our fund) counts as your Required Minimum Distribution, but you can avoid taxes on it!
- Donate agricultural commodities! Just instruct your elevator or broker to donate a certain number of bushels or head of livestock to the North Dakota Community Foundation (for the Wishek fund). If you donate the commodity BEFORE it is sold, you don't have to count the sale as income AND you can deduct the cost of production.
- Make the North Dakota Community Foundation (Tax ID#45-0336015), and specifically our fund, the beneficiary of your life insurance policy or a partial beneficiary of your estate.
- Take advantage of the tax credit. Individuals that give at least \$5,000 in one calendar year and businesses that donate ANY amount to the Wishek Area Community Foundation may take a 40% state income tax credit on their gift. This generous incentive can make a significant difference at tax time!
