\$5,410 Awarded in 2025

The Adams County Community Foundation awarded five grants from its endowment fund earnings in November to the following organizations:

- Second Forty Club:** \$2,000 for a smart TV/Wifi project
- Dakota Buttes Historical Society:** \$1,085 to replace lighting in the museum
- Adams County Food Pantry:** \$1,000 for the Hettinger Back Pack program
- Hettinger Park District:** \$1,000 for the Hettinger Christmas lighted park
- Women Empowering Women:** \$325 for Life Vac Units for Child Care Providers

Grant applications are accepted once a year and reviewed by the local Advisory Committee.



A 2024 grant from the Adams County Community Foundation helped purchase supplies for the Adams County Food Pantry, which provides food for between 50 and 55 families every month.

Generous Tax Credit Provides Big Incentive To Give

The North Dakota Charitable Income Tax Credit, passed by the ND State Legislature in 2011, allows individuals that donate \$5,000 or more and businesses that donate any amount to qualified North Dakota endowment funds to receive up to a 40% state tax credit.

The Adams County Community Foundation (ACCF) is managed as a "qualified ND endowment fund" so donations may qualify for the tax credit if they meet the above criteria.

Depending on your tax bracket, this means a \$5,000 gift to the ACCF may end up only costing about \$2,000 after taking advantage of the tax credit and other deductions! (see chart below) Several ACCF donors have taken advantage of this tax credit.

Gift Amount	\$5,000	\$10,000	\$25,000
Estimated Federal Tax Savings	(\$960)	(\$1,920)	(\$4,800)
ND State Income Tax Credit	(\$2,000)	(\$4,000)	(\$10,000)
Net Cost of Gift	\$2,040	\$4,080	\$10,200

The credit can be carried forward for three additional tax years, if it cannot all be used in one year.
