2022 Annual Update

We had a great turnout for the All Class Reunion Open House over the 4th of July. Thanks again to 1972 Hatton High School graduates Dave Lee and Paul Twenge for serving as emcees. The event raised over \$12,000 for our fund.

\$2,800 Awarded in 2022

The HACF was created to be a resource to support local community initiatives which provide a higher quality of life in Hatton. This year, the HACF Advisory Committee awarded 3 different grants totaling \$2,800 (twice our 2021 amount!) to the following organizations:

- \$1,000 for a Little Hatton Park Board: League Homerun fence
- **Hatton Helping Hand Food Pantry:** \$1,000 to stock the shelves of the food pantry
- Hatton Eielson National Honor Society: \$800 for start up costs for the National Honor Society

Grants are awarded annually. Any local organization with a 501(c)(3)status or government agency may apply. Applications are available online at www.NDCF.net/Hatton.

What is Our Potential?

There are over 69 local community foundations in North Dakota, some that started over three decades ago and others that started last year.

The larger these permanent endowment funds grow, the more earnings are available for grants every

year. Some funds award over \$40,000 in grants every year!


Can you help us grow our fund so that we can better support the programs and projects that make Hatton great? Consider setting up a recurring gift online or send a check to our address at the right.

Other ways to give include:

- Donate stock
- Take advantage of the IRA Charitable Rollover - your donation (directly from your IRA account to our fund) counts as your Required Minimum Distribution, but you can avoid taxes on it!
- Give memorial gifts to our fund in honor of family members and friends.
- Donate agricultural commodities! Just instruct your elevator or broker to donate a certain number of bushels or head of livestock to the North Dakota Community Foundation (for the Hatton fund). If you donate the commodity BEFORE it is sold, you don't have to count the sale as income AND you can deduct the cost of production.

Don't Forget About the Tax Credit

The North Dakota Charitable Income Tax Credit, passed by the ND State Legislature in 2011, allows individuals that donate \$5,000 or more and businesses that donate any amount to qualified endowment funds to receive up to a 40% state tax credit.

Depending on your tax bracket, this means a \$5,000 gift to HACF may end up only costing about \$2,000 after taking advantage of the tax credit and other deductions! (see chart below)
