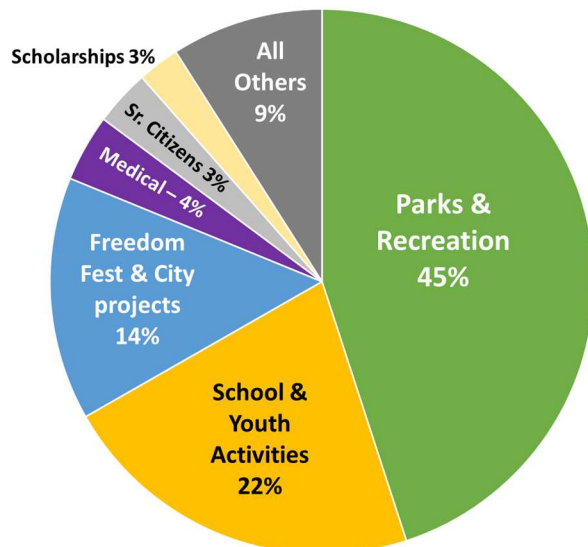

## Our Partnership

We encourage each social group, individual, business, gambling institution, etc. to make some sort of gift from time to time. Over the years, all those gifts will grow this permanent fund to be an even more valuable resource for our communities.

We currently have approximately \$154,000 in assets in our community foundation. We would like to grow this amount so that we can make larger grants every year. The chart below shows other community foundations in North Dakota and the impact their funds have in their area.

Fund	Asset Value	Approx. Annual Grants
Kenmare	\$256,000	\$10,000
Parshall	\$354,000	\$14,000
Stanley	\$2.5 million	\$100,000

## How to Donate to the Fund
