The Glen Ullin Community Foundation Advisory Committee awarded \$5,606 in seven different grants in 2019 to the following organizations:

- **Glen Ullin Community Hall of Fame** for the annual Glen Ullin Hall of Fame Recognition & Awards weekend: \$871.2
- **Glen Ullin Fire District** for Wildland personal protection equipment: \$871.2
- **Glen Ullin Public School** for the Summer Blast program: \$500
- **Best Friends Mentoring Program** for school-based mentoring: \$750



Where Have Our Grants Gone Over the Years?

The Glen Ullin Community Foundation has awarded over \$39,000 in 37 different grants over the last 7 years to various organizations and entities in our area. Here is a breakdown of where those grant dollars have gone:

The Benefits of a Charitable Gift Annuity

If you would like to leave a gift to the Glen Ullin Community Endowment Fund, but still need some income now, consider a Charitable Gift Annuity.

A person can take an asset that is not producing a large amount of income, such as cash, stocks or a CD, and gift it to the North Dakota Community Foundation (our partner) for the benefit of our community's endowment fund.

The donor will then receive an annual payment based on their initial gift. The rates for gift annuities are particularly attractive in today's market place.

In addition to the increased income, donors are entitled to take a current income tax charitable deduction and in certain cases a ND Income Tax Credit for a percentage of the gift. The Annuity can pay the donor (and their spouse, if they choose) a lifetime income. The remaining

principle* is placed in a fund or funds at NDCF, designated by the donor at the time of the gift.

NDCF can provide free illustrations showing the specific annuity rate and tax deduction information for you. There is no charge for these consultations and no obligation. If you'd like more information about this option, contact John Heinen of NDCF at 701-590-4614.
