\$117,848 Awarded in April

The LACF Advisory Committee awards grants in two grant rounds every year - once in the spring and once in the fall. Here are the most recent grant awards from April 2022:


- Riding For Dreams Adaptive Riding Program: \$40,000 to build an indoor arena
- Lisbon Bissell Golf Club: \$20,000 for a new mower
- Ransom County Fair Association: \$12,580 for speakers and sound system
- Lisbon Park District: \$8,500 for additional tables, benches and chairs in Sandager Park and the Pavilion
- CHI Lisbon Health: \$7,868 for an endoscopic CO2 regulation unit
- Abuse Resource Network: \$7,000 to help with legal fees
- Lisbon Recreation Board: \$5,000 for the Rose Street landscape projects
- Sheyenne River Valley Scenic Byway
 Association: \$5,000 for the Sheyenne
 River Water Trail
- Lisbon Public School District #19: \$4,000 for the Lisbon Weekend Backpack Program
- **City of Lisbon:** \$3,000 for 2022 spring flowers and a green space umbrella
- CHI Health at Home Home Health & Hospice: \$2,500 for the We Honor Veteran's Program, volunteer training, and bereavement support
- The House of Everyday Learning: \$2,400 for a Mobile Therapy Unit

Planned Giving Options

There are many ways to make a planned gift to the Lisbon Area Community Foundation (LACF) that have tax benefits and may be of interest to our residents:

- IRA Charitable Rollover Individuals that are 70 1/2 or older may make gifts of up to \$100,000 directly from their IRA to the North Dakota Community Foundation, benefiting the LACF. You can avoid taxes on the amount you transfer and satisfy your required minimum distribution (RMD), if you are over 72.
- Charitable Gift Annuity (CGA) A Charitable Gift Annuity is a contract between a charity and an individual. The individual, referred to as the donor, transfers property to the NDCF for the LACF and NDCF promises to pay a given amount at the end of each selected payment period to one annuitant for life or two annuitants for both lives (usually the donor or the donor and his/her spouse). The remaining principle is put in the LACF when they pass.
- Bequest A bequest is property or money that you promise in your will to give to another person or organization after you die. If you would like to leave some or all of your estate to the LACF, the bequest language is as follows:

"I give and bequeath to the North Dakota Community Foundation (Tax ID 45-0336015), a qualified charitable organization under IRS 501(c)(3), located in Bismarck, North Dakota, (a percentage of the estate, specific dollar amount, or remainder of estate) to the **Lisbon Area Community Foundation**, a component fund of the North Dakota Community Foundation."
