

Who We Area

Established in 2012 by a group of concerned residents, the Killdeer Area Community Foundation is a permanent endowment fund that can support our community for years to come. Earnings from the fund are given as grants to support nonprofit projects or programs in Greater Dunn County that work to improve our community and quality of life. Anyone who would like to contribute to the fund can do so at any time.

How We Serve

The local committee serves as a conduit to the community for the fund. The committee helps with promoting, inviting new membership, taking applications, awarding grants, and thanking those who contribute to the fund.

When families or individuals leave Legacies, the committee then helps analyze the most urgent needs of the community, and directs funds to that program/project. They can facilitate giving even when those who gave are no longer in the community or have passed away. In this way, the fund is a "Living Legacy" for the general urgent needs of the community.

The goal is to build the fund large enough to help support "GAP" needs in the community. Energy production comes and goes, agriculture has good and bad years, government funding of services fluctuates year to year. This fund, however, as it grows, will provide a consistent revenue to fill in where other areas fall short to support services we all value and enjoy. Those who love their community, and want to see friends, family, and neighbors enjoy a good quality of life are asked to consider helping build the fund.

Grants are made every year from its interest earnings to worthwhile projects and programs in Dunn County. We made our first grant in 2017(\$500 to the Christmas for Kids program at Dunn County Social Services)! Here are some examples of projects that other community foundations have supported:
