It was established in 2014 as a component fund of the North Dakota Community Foundation (NDCF) with a gifts from several local residents. What is a Community Foundation?

A community foundation receives gifts and donations from individuals, families, and businesses, and grants money back into the community for projects and programs that improve the quality of life for area residents.

The community foundation is guided by a local Advisory Committee, which leads fundraising efforts and recommends grant awards.

The Williston Area Community Foundation's assets are invested and a portion of the earnings every year are available as grants. This means the Foundation is a permanent resource for the area, providing funding to nonprofits in perpetuity.

"The beauty of a fund like this is that it's not tied to any one cause or organization," said John Heinen with NDCF. "Each year, the Advisory Committee will review applications from charitable organizations and community groups and recommend programs to receive funding."

The Williston Area Community Foundation has awarded four grants since its inception:

- Williams County Social Services: \$2,090 for school supplies for foster care youth
- MonDak Gymnastics Support Group: \$715.60 for new windows, door replacement, and roof repair
- Williston Council for the Aging, Inc: \$1,073.40 for route match software for Northwest Dakota Public Transit
- Summit Counseling, Inc.: \$2,330 for **COVID Protection**

What Could Williston Do?

NDCF manages 69 community foundations in the state. The larger the fund, the more and larger grants that can be awarded, as shown in the chart below:

Community Fund	Approx. Total Assets	Average Annual Grants

McKenzie Co.	\$381,000	\$15,240
Stanley	\$2.4 M	\$96,000

Examples of projects that other communities with endowment funds have

supported include:

- New equipment for their Fire Department
- Made area buildings handi-capped accessible
- Books & supplies for their library
- A downtown restoration project
- Support for their local Meals on Wheels program
- Building repairs for their local daycare
- Repairs to their Senior Citizens Center
- Equipment for their local clinic
- Playground improvements
- New facilities for their park district

Ways To Give: Options to Grow Our Fund

There are many easy ways to support our community's permanent endowment fund:

- Sign up online to make a recurring gift every month. Just \$25 or \$30 a month would make a difference. Together, these gifts from area residents would grow our fund into a huge resource for our schools, park district, library, and other nonprofit organizations!
- Establish a Charitable Gift Annuity
 through the North Dakota Community
 Foundation, which manages our fund. You
 will receive an annual payment for the rest
 of your life, and the Williston Area
 Community Foundation will get the
 remainder of your gift when you are gone.
- Leave a portion of your estate to the fund.
- Make the fund a full or partial beneficiary of your life insurance policy.
- Take advantage of the IRA Charitable Rollover. Individuals 70 1/2 or older can transfer any amount up to \$100,000 to the Williston Area Community Foundation in one calendar year. You avoid taxes on the amount you transfer, but it still counts toward your Required Minimum Distribution!
- Take advantage of the tax credit.

 Businesses that give any amount and individuals that donate at least \$5,000 in one calendar year to the Williston Area Community Foundation are eligible for the state's 40% income tax credit. This can make a big difference at tax time talk to your financial advisor.
