# 2025 Annual Update

A Status Update for Donors and Supporters of Park River's Permanent Endowment Fund.

## Dear Friends,

An article last year in The Chronicle of Philanthropy noted that rural areas in America receive much less charitable funding from national foundations than they should based on population. This doesn't come as a big surprise to many of us who live in "flyover country." The Midwest and especially its rural areas are often overlooked.

While this statistic may be discouraging to some, it is actually *inspiring* to our committee. We don't wait for help or handouts from national organizations to build projects or support programs here in Park River - while we appreciate any support we can get, we are busy building our own charitable resource in the Park River Area Community Endowment Fund.

The PRACEF is led by a local Advisory Committee. We focus on growing the fund and reviewing grant applications every year to recommend grants.


Christian Temperance Union Fountain. Signs at each location include a QR code and phone number for people to hear oral stories about the historical significance of each place.

#### **Fund Growth Over the Years**

The Park River Area Community Endowment Fund ended 2024 with a market value of more than \$744,000! This is a permanent fund so that money will provide grant dollars for our area forever.

How did we get to this amount? First, a group of local residents had the forethought to create this fund at the North Dakota Community Foundation back in 1983. Then, many people have donated to this fund over the years, either through fundraisers or by sending in a check. In fact, more than 125 different individuals and businesses have made contributions to this fund since our inception. This is truly a COMMUNITY foundation!

The chart below shows the **fund balance as of December 31 every year** since it started through 2024. How exciting to see that growth!



In addition to the current market value of our fund, we have awarded over \$372,000 in grants since our inception!

# Generous Tax Credit Provides Big Incentive To Give

Are you able to make a more substantial gift to our community foundation? If so, you may be interested in the significant tax benefits available to you.

The North Dakota Charitable Income Tax Credit, passed by the ND State Legislature in 2011, allows individuals that donate \$5,000 or more and businesses that donate any amount to qualified endowment funds to receive up to a 40% state tax credit.

The Park River Area Community Endowment Fund (PRACEF) is managed as a "qualified endowment fund" so donations may qualify for the tax credit if they meet the above criteria. Several donors have already taken advantage of this incentive and contributed to our fund.

Depending on your tax bracket, this means a \$5,000 gift to the PRACEF may end up only costing about \$2,000 after taking advantage of the tax credit and other deductions!

Gift Amount	\$5,000	\$10,000	\$25,000
Estimated Federal Tax Savings	(\$960)	(\$1,920)	(\$4,800)
ND State Income Tax Credit	(\$2,000)	(\$4,000)	(\$10,000)
Net Cost of Gift	\$2,040	\$4,080	\$10,200

The credit can be carried forward for three additional tax years, if it cannot all be used in one year.
