# POWERS LAKE Community Foundation Update

The Powers Lake Community Foundation (PLCF) reached two great milestones this year - we have grown to over \$50,000 in total assets and we've awarded our first grant!

We am so thankful to those who want to see Powers Lake flourish who have provided support to this permanent fund. This is our gift to our region - the money in this fund is invested and a portion of the earnings will be available for grants every year. That means that long after we are gone, the Powers Lake Community Foundation will continue to provide money for projects and programs that improve the quality of life here. We can't think of a better way to "pay it forward" for future generations.

We also awarded our first grant from the fund's earnings in 2021: \$349 to the Powers Lake Food Pantry! The pantry will use the money to help provide holiday food baskets to families in need in the area. We were glad to be able to support this local project and anticipate having more money to grant next year.



### **Fund Growth So Far**

The Powers Lake Community Foundation ended the third quarter of 2021 with a market value of over \$54,000!

How did we get to this amount? The foundation was started in 2019 to provide a permanent charitable resource for our area by a group of concerned residents. Several people made significant contributions that first year to get us started. More recently, Powers Lake Area Development contributed a substantial amount as an investment in our future.

There are many ways to grow our fund and we can accept a variety of gifts, including stock transfers, real estate, and donations of agricultural commodities. The back of this report has instructions on an easy way to give small amounts over time to help us grow!

### The Power of a Recurring Gift

If you'd like to support the Powers Lake Community Foundation, but can't write a big check all at once, consider setting up a recurring monthly gift online. Just \$10 or \$25 every month would help our fund steadily grow and the process is simple! Look at the impact your small monthly gift, invested with an average annual 7% return\*, could have over time:

Monthly gift	Total impact after one year	After two years	After three years
\$10	\$124	\$257	\$399
\$25	\$310	\$642	\$998
\$35	\$434	\$899	\$1,398
\$50	\$620	\$1,284	\$1,997

Now imagine the impact if 30 families in our area set up a recurring gift! When multiple people give in this way (or with a check), their combined giving makes a huge difference for our communities.

# To set up a recurring gift to our foundation, follow the steps below:

- 1. Go to www.NDCF.net/PowersLake
- 2. Click on the "Donate" button on that page.
- 3. Choose "Recurring Donation Amount" and fill in the amount of money you wish to donate every month.
- 4. Follow the instructions to complete the checkout process.

You will receive a tax receipt for your donation and you can change the amount or frequency of your gifts at any time.

## Generous Tax Credit Provides Big Incentive To Give

Are you able to make a more substantial gift to our community foundation? If so, you may be interested in the significant tax benefits available to you.

The North Dakota Charitable Income Tax Credit, passed by the ND State Legislature in 2011, allows individuals that donate \$5,000 or more and businesses that donate any amount to qualified endowment funds to receive up to a 40% state tax credit.

The Powers Lake Community Foundation is managed as a "qualified endowment fund" so donations may qualify for the tax credit if they meet the above criteria. Several donors have already taken advantage of this incentive and contributed to our fund.

Depending on your tax bracket, this means a \$5,000 gift to PLCF may end up only costing about \$2,000 after taking advantage of the tax credit and other deductions! (see chart below)

Gift Amount	\$5,000	\$10,000	\$25,000
Estimated Federal Tax Savings	(\$960)	(\$1,920)	(\$4,800)
ND State In- come Tax Credit	(\$2,000)	(\$4,000)	(\$10,000)
Net Cost of Gift	\$2,040	\$4,080	\$10,200

The credit can be carried forward for three additional tax years, if it cannot all be used in one year.
