What an impact Grid United has had on our area! We have awarded \$140,500 in grants in 2023 and 2024 to organizations in Flasher and the surrounding area for a variety of projects and programs. Unfortunately, we received total requests of over \$453,000 during that same time so we had to make tough choices. There are obviously more needs in our area, but the Grid funding will run out in 2025.

Our invitation to everyone reading this report is to consider donating something of value to our community fund this year so we can continue to provide critical funding for many of these projects, year after year, even after Grid United funding no longer exists. \$58,000 Awarded in Grants

The Flasher Area Community Foundation (FACF) awarded the following grants in 2024:

- **Flasher Rural Fire Protection District:**
 - \$20,000 for a Flasher Fire/Rescue Turck - CAFS Unit
 - \$10,000 for a Flasher Fire Truck Rescue Unit Bed
- **City of Flasher:**
 - \$9,500 to make east side of Main Street handicap accessible (see photo below)
 - \$8,500 for park upkeep and materials for maintenance
- **Flasher Public Schools:** \$10,000 for a parking lot to gym stairs

Any organization with a 501(c)(3) status or government agency that provides services in the Flasher area may apply for a grant. More information and the online application process can be accessed at www.NDCF.net/Flasher.

Give Other Than or In Addition to Cash?

Why, yes you can! The Flasher Area Community Foundation can accept many different types of gifts. Depending on your situation, you may want to consider donating one of the following:

- **Outright Gift of Cash:** Online or by check
- **Over 70 1/2? A charitable IRA rollover (QCD) counts as your required minimum distribution,** but you don't need to claim the donated portion as federal income. Must be sent to NDCF by direct transfer.
- **Gifts of farm commodities:** Avoid income recognition by having the elevator make a direct transfer to the Flasher Area Community Foundation Endowment.
- **Appreciated investment assets,** valued on the date of transfer, are tax deductible and you can avoid paying capital gains tax.

Don't Forget About the Tax Credit

The North Dakota Charitable Income Tax Credit allows individuals with ND earned income that donate \$5,000 or more and businesses that donate any amount to qualified endowment funds to receive up to a 40% state tax credit.

Depending on your tax bracket, this means a \$5,000 gift to the FACF may end up only costing about \$2,000 after taking advantage of the tax credit and other deductions! (see chart below)
