\$14,000 Awarded in 2025

The CCF awarded a total of \$14,000 in 10 different grants in 2025 to the following organizations:

- Cooperstown Medical Center Foundation:
 - \$1,750 for an outdoor respite area at Dakota Regional Medical Center
 - \$1,750 for a NuStep Recumbent cross trainer bike at the Griggs County Care Center
- BIO Girls: \$1,750 for Cooperstown BIO Girls program
- Cooperstown Community **Activities Authority:** \$1,750 for electrical upgrades in the fitness center to support new treadmills
- Cooperstown Golf & Country Club: \$1,750 for golf shed roof repairs and materials
- **Griggs County Historical Society: \$1,750** to build a replica of the Opheim Cabin
- Hospice of the Red River Valley: \$1,000 for the Cooperstown community grief and bereavement program
- Zion Lutheran Church: \$1,000 for Community Vacation Bible School
- Cooper Theatre, Inc.: \$1,000 for funds to help with operating
- Griggs County Central: \$500 for an Artist in Residence

Grant applications are accepted once a year and reviewed by the local advisory committee. All nonprofit organizations and governmental agencies that provide services Cooperstown area are welcome to apply.


Fund Growth Over the Years

The Cooperstown Community Foundation has a market value of more than \$400,000! This is a permanent fund so that money will provide grant dollars for our area forever.

How did we get to this amount? First, a group of local residents had the forethought to create this fund at the North Dakota Community Foundation back in 2007. We received initial, substantial funding from the Griggs Steele Empowerment Zone, the Cooperstown Community Development Authority, and the North Dakota Community Foundation.

Since then, more than 140 different individuals, families, businesses, and organizations have donated to this fund - many of them multiple times - to grow it into the reliable charitable resource it is today.

The chart below shows **our fund's market value on December 31 of every year since its inception**. (The 2025 number is from June 30.) We have come a long way in the last 18 years!
