




## History of the McKenzie County Community Foundation:

# Could one of these be right for you?

In 2018 we had grant requests totaling \$57,000 - we could only help fund a portion of that. Growing our fund will help us get closer to meeting our community need!

- Support our fundraising events!
- Make a gift every year on your birthday.
- Businesses - donate a percentage of your net profit at the end of the year.
- Honor a loved one with a gift in their memory.
- Establish a Charitable Gift Annuity.
- Make the fund a full or partial beneficiary of your life insurance policy.
- Transfer money directly from your IRA to the McKenzie County fund - you don't have to pay taxes on the amount you transfer, but it will count toward your required minimum distribution (RMD) for the year! *(for individuals 70 1/2 or older)*
- Leave a gift in your will - you can leave a certain amount, a percentage of your estate, or the remainder of your estate (after designating gifts to family and friends).
- Individuals who donate at least \$5,000 in one calendar year and businesses that donate ANY amount (up to \$25,000) are eligible for the North Dakota 40% Income Tax Credit! *(Anyone receiving income in North Dakota may qualify for the income tax credit, even if they live out of state.)*
