#### **Philanthropy in Many Forms**

The Oakes Area Community Foundation (OACF) is one of several funds at the North Dakota Community Foundation that support the Oakes area, including

Donations can be made to many of the funds listed above at any time at NDCF.net/Donate.

In addition, individuals or families can establish other funds to support the organizations, schools, communities or charities they would like. Other types of funds at NDCF include:

- Donor-Advised Funds: the donor or their designee(s) recommends grant awards every year.
- Special Purpose Funds: the donor specifies when the fund is created which organizations should receive the grant dollars and NDCF carries out their wishes every year.
- Organizational Endowment: an endowment fund that benefits one particular organization to further their mission.

All of the endowed funds at NDCF are managed as "qualified North Dakota endowment funds" and gifts may qualify for the State 40% Income Tax Credit. Contact Amy Stromsodt for more information about any of these funds, the tax credit, or options for establishing a new fund.

## **Planned Giving Options**

Along with our annual golf tournament and Giving Tuesday campaign, there are also opportunities to make other types of gifts, including planned gifts to the Oakes Area Community Foundation (OACF) that may be of interest to our residents:

- IRA Charitable Rollover Individuals that are 70 1/2 or older may make gifts of up to \$100,000 directly from their IRA to the North Dakota Community Foundation, benefiting the OACF. You can avoid taxes on the amount you transfer and satisfy your required minimum distribution (RMD), if you are over 72.
- Charitable Gift Annuity (CGA) A
   Charitable Gift Annuity is a contract between
   a charity and an individual. The individual,
   referred to as the donor, transfers property to
   NDCF for the OACF and NDCF promises to
   pay a given amount at the end of each
   selected payment period to one annuitant for
   life or two annuitants for both lives (usually
   the donor or the donor and his/her spouse).
   The remaining principle is put in the OACF
   when they pass.
- Bequest A bequest is property or money that you promise in your will to give to another person or organization after you die. If you would like to leave some or all of your estate to the OACF, the bequest language is as follows:
